

Sea Trial Rules S.718 Disney Treasure

Dear employees,

We look forward to working with you on the completion of our next new building "S.718 - Disney Treasure". Our common goal is to hand over this ship to our client in perfect condition and on time, to inspire tourists all over the world with our product.

You have all done a great deal to prepare this complex project for the next milestones: the river Ems conveyance and sea trials.

During this time, there are still challenging tasks to be done, which we can only master together as a team and which can only be successfully completed if everyone involved adheres to the applicable rules, which we explain to you step by step below:

1.0 General Regulations

1.1 Authority to issue instructions

The instructions of the captain, project management and security personnel must be followed.

1.2 Identification requirement

Upon boarding the ship, you will receive an on-board pass, which must be visible. The issuance of the boarding pass is only possible upon presentation of a valid Passport or ID card which is valid for at least 3 months.

1.3 Check-in and check-out

When entering or leaving the ship, check-in and check-out at the respective terminals is mandatory.

2.0 Prohibitions

For the safety of all persons on board, failure to follow the rules below will result in an immediate ban from the ship and, under certain circumstances, staff-related consequences



Smoking is only permitted in designated areas. As a precautionary measure, it is pointed out that smoking is also prohibited on the balconies and in the cabins.



There is a strict ban on alcohol on board. It is not allowed to bring, or drink alcohol on board. Suspicious people under the influence of alcohol are not allowed on board. Checks are done in case of abnormalities. From a breath alcohol level of 0.3, access to the ship will be denied and staff-related consequences must be expected.



There is a strict ban on drugs on board. Drugs may not be brought on board or consumed there. Persons under the influence of drugs are not allowed to enter the ship. Checks are done in case of abnormalities.



There is a strict ban on weapons on board. Weapons may not be brought on board. Checks are carried out.

Hint:

In addition to people, bag and baggage checks, the safety of all persons on board is also supported by CCTV.



3.0 Emergency Signals

In the event of an emergency, the general alarm sounds over the on-board loudspeakers (7 short tones followed by a long tone)

4.0 What to do in an emergency

4.1 General alam

When the general alarm sounds (see 3.0), please proceed to the

all employees of MEYER WERFT and partner companies to their meeting point

"Entertainment Restaurant" - Deck 05 Fire zone 1

all employees of the shipping company to their meeting point

"Theatre" - Deck 03+04 Fire Zone 6

→ during the ship's laytime

In the port: via the gangways to the designated assembly points

4.2 Smoke and fire

Ш	Shout "Fire, fire!" to alert other people
	Press the nearest fire alarm button
	Call the emergency number 5555 (bridge) and provide detailed information to the
	guard on duty
	In the event of a minor fire, take a nearby fire extinguisher and try to extinguish
	the fire
	If this does not work, or the fire is too large, close the doors and leave the danger
	zone

4.3 Person overboard ☐ Shout "Person overboard!" to alert other people to the danger ☐ Immediately throw down a lifebuoy ☐ Call the emergency number 5555 (bridge) and provide detailed information to the guards on duty ☐ Try to keep the person overboard in your field of vision				
4.4 Evacuation from ship to sea Please pay attention to the announcements and go to your assembly station immediately.				
5.0 Emergency drill According to international regulations (SOLAS), participation in a rescue exercise is mandatory for all persons on board before the ship sets sail.				
The emergency drill will be announced over the on-board P/A system. After the general alarm sounds, please go to your assembly station on board as described in point 4. You don't need a life jacket for the exercise.				
6.0 Working Rules				
For the safety of all people on board, rules must also be observed for the remaining work to be carried out during the sea trial and during the laytime, which we summarize below. Violations will result in immediate ban from the ship and may result in personal consequences: All tests and trials must be coordinated with the sea trial management / project management in advance. The unauthorized execution of tests is strictly forbidden Work that must be carried out at the same time as tests or trials must be coordinated in advance with the sea trial management / project management and the site office Work on the control, driving and safety elements of the ship is generally forbidden. Exceptions can only be approved in written form in advance by the ship's management On board, there is an absolute ban on burning, welding, cutting and grinding (hot works) Exceptions can only be approved in written form in advance by the fire department Hot work permits can be applied at the

with one day's notice. ☐ Workplaces must be tidied up and cleaned daily at the end of work ☐ Waste must be collected, bagged and disposed of at the designated collection points (containers) daily ☐ Traffic and rescue routes (e.g. stairwells, emergency exits and areas of the roller shutters) are always free of tools and materials ☐ Fire-resistant doors must always be kept closed. Cables and hoses must be laid through the flaps provided for this purpose				
☐ Flammable liquids, such as paints, cleaners or thinners, must be stored in a marked aluminum box.

	Always ensure that ladders and racks are firmly in place and secure them additionally, as sudden ship movements can occur at any time during the sea trial. Please note that if the conditions are right, the work must be temporarily stopped for safety reasons	
	Fix and fasten installation parts as well as tools so that they hold in rough seas. Only straps and suitable ropes are permitted as lashing material and must be provided for this purpose. In case of need, lashing material is available on board on request. Everyone is responsible for ensuring that tools and materials are adequately secured, both in their work area and in their cabin. Damage caused by improper or inadequate securing may be charged to the perpetrator	
	It is generally not permitted to use your own locking cylinders on store premises. In valid cases, the use of a separate locking cylinder must be coordinated with the ship's safety. The decommissioning of door closers and lock systems without consulting the ship's management will be considered an interference with the ship's safety and will be punished	
	with a ban from the ship All tool and material boxes must be clearly marked with the name, cabin number and telephone number of the person responsible. In addition, the weight of the boxes must be marked on the box

9.0 Information for persons with an engine room authorization

Please note the separate information for persons who are entitled to enter the engine room due to work to be carried out (Appendix 1)

Compliance with the rules is for the safety of all people on board and must therefore be strictly adhered to. Please understand that violations of the rules may result in consequences under personnel law and exclusion from the sea trial.

We reserve the right to amend these rules if necessary. In the event of an adjustment, we will inform you accordingly.
